

NOTICE-AND-ACCESS NOTIFICATION TO BENEFICIAL SHAREHOLDERS

Notice-and-Access

You are receiving this notification because Prairie Provident Resources Inc. ("**Prairie Provident**" or the "**Company**") has, in respect of its annual and special meeting of shareholders to be held on May 16, 2019 (the "**Meeting**"), elected to use the "notice-and-access" system to distribute proxy-related materials to those of its shareholders who do not hold their common shares of the Company ("**Common Shares**") in their own name ("**Beneficial Holders**").

Pursuant to the notice-and-access system, Beneficial Holders are receiving this notification instead of paper copies of the Company's notice of meeting and information circular dated April 5, 2019 together, the "**Circular**"). Prairie Provident is providing this notification to Beneficial Holders who have indicated that they wish to receive proxy-related materials of the Company, and through it provide basic information about the Meeting and the matters to be voted on at the Meeting as well as instructions how to access the Circular electronically through the internet or, if desired, to obtain a paper copy of the Circular.

Distributing the Circular using the notice-and-access system is expected to substantially reduce printing and mailing costs to the Company and lessen the environmental impact of unnecessarily producing and distributing unwanted paper copies.

Matters to be Voted on at the Meeting

At the Meeting, shareholders will be asked to consider and vote on the following matters.

- 1. *Election of Directors.* Shareholders will be asked to elect directors of the Company for the ensuing year, to hold office until the next annual meeting. Information regarding the election of directors and proposed director nominees may be found in the Circular, particularly under the heading "*Matters to be Acted upon at the Meeting Election of Directors*".
- 2. Appointment of Auditor. Shareholders will be asked to appoint Ernst & Young LLP, Chartered Professional Accountants, as the auditor of the Company for the ensuing year, to hold office until the next annual meeting. Information regarding the proposed appointment of Ernst & Young LLP as auditor may be found in the Circular, particularly under the heading "Matters to be Acted upon at the Meeting Appointment of Auditor".
- **3.** Approval of Unallocated Entitlements under Equity Compensation Arrangements. Shareholders will be asked to approve unallocated entitlements under the Company's stock option plan and incentive security plan (together, the "Plans") and authorize further grants of incentive stock options and share unit awards thereunder. Information regarding the proposed approval of unallocated entitlements under the Plans may be found in the Circular, particularly under the heading "Matters to be Acted upon at the Meeting Approval of Unallocated Entitlements under Equity Compensation Arrangements".

4. Other Business. Shareholders may also be asked to consider such other business as may be properly come before the Meeting. Information regarding the exercise of discretionary authority to vote on any such other business may be found in the Circular under the heading "Voting of Proxies". As noted in the Circular, management of the Company knows of no proposed amendments or variations to the above matters of business or any other matter proposed to come before the Meeting.

SHAREHOLDERS ARE REMINDED TO <u>REVIEW</u> THE CIRCULAR <u>BEFORE</u> VOTING.

In order to allow a reasonable time to receive and review a paper copy of the Circular in advance of the proxy deposit deadline as set out in the accompanying form of proxy or voting instruction form, Prairie Provident estimates that any Beneficial Holder wanting a paper copy of the Circular should request it no later than 4:00 p.m. (Calgary time) on May 3, 2019.

<u>Voting</u>

Shareholders who receive a voting instruction form (VIF) from Broadridge Financial Solutions, Inc. ("**Broadridge**") or otherwise from the brokers or other intermediaries through which the Beneficial Holders hold their Common Shares, must return the completed VIF to Broadridge or to such other party as their broker or other intermediary may direct, or otherwise communicate voting instructions to Broadridge or such broker or other intermediary, in the manner that Broadridge or such broker or other intermediary directs, in order for their Common Shares to be properly voted at the Meeting (or any adjournment thereof).

Shareholders who receive a form of proxy directly from Alliance Trust Company, the Company's registrar and transfer agent, are invited to return a completed proxy at least 48 hours (excluding Saturdays, Sundays and statutory holidays) before the time of the Meeting (or any adjournment thereof) using one of the following methods, in order for their Common Shares to be properly voted at the Meeting or any adjournment.
